PETITION FOR REMOVAL FROM GANG INJUNCTION

This form is for use by a person who has been served with an Orange County gang injunction and who wants the opportunity to demonstrate that he or she should not be restrained by the gang injunction because he or she no longer is, or never was, a gang member.

CONFIDENTIALITY

The District Attorney's Office will keep the information you provide in this petition confidential to the extent permitted by law. The District Attorney's Office will not use statements made in this petition to prove any fact essential to proving any criminal charge the District Attorney's Office may bring against you in the future. However, this information may still be used to cross-examine you should you testify at a trial in a case brought by the District Attorney's Office and should your testimony be inconsistent with the information provided in this petition.
